The Government of Maharashtra has been prescribed the percentages of reservation for students admission in Educational Institutions for the various courses as mentioned below :

7	Other Backward Classes (OBC)	19 %
8	Open	50 %

- ❖ The College/Institution admission authority has to reserve the seats for admission for Backward class candidates as per rules of the Govt. of Maharashtra up to the last date of admission.

- 1 For Female candidates 30% seats are reserved at graduate level as per G.R.No.GEC-2000 (123/2007)/T.E. I dated 17/4/2000.
- 2 For disabilities candidate 3% seats are reserved as per Govt. letter No.Misc.1003/(510/2003) Est. dated 27/10/2003.

General instructions for admission Process -

- i) A consolidated list arranging all the applications irrespective of caste of categories in the order of merit is to be prepared.
- ii) Initially 50% open seats as per merit list are to be filled in.
- iii) There after 50% reserved seats are to be filled in from reserved category students as per prescribed percentage.
- iv) The students from reserved categories, who are selected on merit, have to be treated as open category students. As such there will not be any objection, if the percentages of reserved category students exceeds 50% (Govt. No.UGC-1493/(2428)WS-4 dated 7/2/1996)
- v) (Note ; As per G.R. No.TEM/3397/12926/(9086)/TE-1 dated 11/7/1997 the constitutional reservation should not exceed 50% and hence the necessary adjustment is to be made for giving reservation to S.B.C.as per G.R.)
If students belonging to particular B.C. category are not available for admission as per quota of that particular category, other students belonging to B.C category should be considered for admission. If the seats are still vacant due to non-availability of students belonging to B.C category then students from open category should be admitted with prior approval from the College sanstha Special Cell Standing Committee.
- vi) Students belonging to creamy layer amongst the categories (except SC/ST) are not entitled to take reservation facilities as per Government Order No.CBC/2006/VK/15/Mavak 5 dated 30 June, 2006.

The guidelines issued by the University Grants Commission vide its letter No. D.O.F.1-6/99/SCT dated 11/5/2000 circulated vide outward No. SU/Special Cell/F.20/305 dated 4/7/2000 should also be taken into consideration for admission process.

As per the directions of the University Grants Commission, the implementation reports of admissions given to reserved students, in the enclosed prescribed proforma are collected from this office, every academic year. While filling the information, in the given proforma, the following instructions be taken in to account :

- vii) No fees should be charged to the eligible and applied reserved category candidates for Scholarship/Freeship as per the Govt Resolution (महाराष्ट्र शासन सामाजिक न्याय, सांस्कृतिक कार्य, क्रिडा व विशेष सहाय्य विभाग,) No इबीसी.२००३/प्र.क्र./३०१/मावक-२ दि-०१/११/२००३

General Instructions for filling the proforma of the statistical information of admission:

- 1) The information regarding admission to various courses and the information regarding hostel admission is to be furnished **in one hard copy and in soft copy also. Soft copy should be sent on mail : statcell@unishivaji.ac.in**
- 2) Every particular of the proforma be considered while filling the information.
- 3) In case, if there is no hostel, the NIL report should be sent.
- 4) In case there is central admission process (like Engineering, B.Ed., B.A. B.Ed., M.B.A.M.C.A etc.) the information about admitted students only, should be furnished after completion of admission process.
- 5) The information related to Minority Students & Physically Handicapped Students should be provided as per proforma.
