

Within the sanctioned posts according to workload, additional / earlier posts are approved by the office provide by the following conditions.

1. It is necessary to have actual classes, division, subjects wise students strength mentioned in the proposal.
2. It is necessary to have the periods prescribed for lectures/practical/tutorials/ project work according to various government rules.
3. The first year and third year science faculty practical batch should be minimum 20,16,12 and 20,16.
4. The subject period should be as per the time table. The teachers who have 12 periods or who have less than 18/20 periods should be given workload of junior college or the extra workload of the same subject.
5. The appointments on the said posts are according to prevailing rules and regulations of the Government.



6. The minimum students strength of Subject/Faculty/division should be as per the rules made by the Government.
7. It is necessary the all concerned students strength /subject/divisions/syllabus/faculty should be approved for 100% grant.
8. The college should have the letters and Government Resolutions of sanctioning 100% grants for concerned subjects/divisions.
9. If the strength of students is not fulfilled in the next academic year or with any other reason the grantable workload is depleted, the post of the teachers will be lessened.
10. The list of surplus teachers should be taken from Director of Education before appointing new teachers.

According to GR Dated 13/2/2000 and 16/6/2000 the recruitment of non qualified, Non Net Set and Open posts are banned. Such appointment will be considered as CHB appointments. As per GR dated 2/07/2001, vacant two third posts should not be recruited without prior permission of this office.

The CHB teachers should be allocated more than 7 periods, if so the grants will be rejected.

The salary expenses of the appointments on the said posts, will be sanctioned by this office for grant while assessment of grants provided the fulfillments of above conditions. If it is rejected for grants, the college will be held responsible for this.
