1. PREAMBLE:

Students during first year of their degree course are acquainted with Indian Constitution and Indian Government. Along with this they are provided courses like Rural Local Self Government and Urban Local Self Government under SEC. In second year students completed study of papers like- Maharashtra Government, Indian Political Thinkers, Public Administration, Union Government, Concepts of Political Science, Election Management, History of Indian Democracy, Political Process in Maharashtra, State Government, Media and Politics etc. under different verticals as per applicable. Those who have successfully completed his/her second year is eligible for third year of degree course.

This syllabus is prepared for third year of degree course. In third year we are going to study – Papers mentioned in point number 8 under Course Code details.

Contents of the syllabus in these papers is going to provide theoretical and practical knowledge of political science. Students will be familiar with different schools of thoughts. Moreover, some practical based activities are going to be undertaken to support the theory of Political Science. Thus after successful completion of third year student will be eligible to award degree.

2. PROGRAMME LEARNING OUTCOMES (POs)

- Students will be able to compare political thoughts of different western thinkers.
- Students will be familiar with Political Theories and Political Ideologies
- Students will be familiar with International Relations and International Organizations.
- Students will be able to understand modern political concepts and political science in its applied aspects.
- Students will be familiar with political system in UK and USA.

3. DURATION:

BA in Political Science programme shall be a FULL TIME COURSE of 3/4 years that is 6/8 Semesters duration with 22 credits per semester. (Total Credits = 132/176)

4. ELIGIBILITY FOR ADMISSION:

The candidate who has qualified BA II year or BA Diploma Course or Equivalent is eligible for admission for third year degree course. The criteria for admission is as per the rules and regulations set from time to time by concerned departments, HEIs, university, government and other relevant statutory authorities.

5. MEDIUM OF INSTRUCTION:

The medium of instruction shall be ENGLISH or MARATHI. The students will have an option to write answer-scripts in English or Marathi.

6. EXAMINATION PATTERN:

The pattern of examination will be Semester End Examination with Internal Assessment/ Evaluation.

NOTE: Separate passing is mandatory for both, Semester End Examination and Internal Evaluation/Assessment. (Annexur-I)
